The General Manager / Chief Operating Officer ("GM/COO") is a visible, energetic and ethical leader of Dubuque Golf & Country Club ("Club") and has overall responsibility for the management of all operations of the Club. The GM/COO will demonstrate a management / leadership style that evokes a favorable club culture that engages members as well as staff to carry out their responsibilities to achieve member satisfaction. The GM/COO will have a proven and thorough understanding of all phases of club operation including food & beverage, golf course & golf shop, aquatic center, tennis, other recreational outlets and facility / building mechanicals. The GM/COO must have financial management acumen to carry-out the club's annual and long-term financial direction plus the ability to develop programs that recruit and retain members. The GM/COO is a key player in strategic guidance and long range planning. The GM/COO reports to the Board of Directors through its President and is responsible for both carrying out the Club's policies and adhering to the protocols of the Club's governance documents. The GM/COO is an integral part of the Board of Directors, Board of Trustees and Standing Committees. The GM/COO prepares meeting agendas, implements and monitors programs and initiatives, and provides reports on Club direction, activities and programs.

The GM/COO supervises the Clubhouse Services Manager, Controller, Communications and Marketing Director, Executive Chef, Banquet and Catering Manager, Head Golf Professional, Golf Course Superintendent, Aquatic Center Director, Tennis/Fitness Director and Building/Facilities Superintendent.

The current General Manager is retiring after 16 years of service to Dubuque and Golf Country Club.
